**VERIFIED PETITION FOR WRIT OF  
MANDATE ORDERING COMPLIANCE WITH  
THE CALIFORNIA PUBLIC RECORDS ACT**

[Government Code §§ 6250 *et seq.*; Code of Civil  
Procedure § 1085]

1. Petitioner seeks a writ of mandate requiring Respondent to immediately make available code-compliant public records requested pursuant to the California Public Records Act (“CPRA”), Government Code § 6250, *et seq.* Petitioner also respectfully requests this Court grant relief in the form of costs of suit, attorney’s fees, and other appropriate and just relief resulting from Respondent’s unlawful conduct.

**PARTIES**

2. Petitioner, Los Angeles Sunshine Coalition (“LASC” or “Petitioner”), is an unincorporated association that uses public records requests to collect and publish information about government activity in the Los Angeles area. LASC advocates for transparency in government records and public meetings. For example, LASC recently testified before the Senate Committee on Governance and Finance regarding potential changes in California open government law. LASC is a member of the public within the meaning of §§ 6252(b)-(c).

1 3. Respondent the City of Torrance (“Respondent”) is a local public agency within the  
2 meaning of Gov. Code §§ 6252(a), (d).

3 **JURISDICTION AND VENUE**  
4

5 4. This court has jurisdiction over this petition pursuant to Gov. Code §§ 6258 & 6259,  
6 Code Civ. Proc. § 1085, and Article VI, Section 10 of the California Constitution.

7 5. Venue is proper in this Court. The records in question, or some portion of them, are  
8 situated in the County of Los Angeles, Gov. Code § 6259; the acts or omissions complained of  
9 occurred in the County of Los Angeles, Code Civ. Proc. § 393; and Respondent is located in the  
10 County of Los Angeles, Code Civ. Proc. § 395.

11 **ALLEGATIONS**  
12

13 6. This dispute arises from the failure of the City of Torrance to respond to a request for  
14 public records.

15 7. **Petitioner’s request for public records:** On September 27, 2022, the Petitioner  
16 requested a roster of sworn Torrance police officers including specific information— name, rank,  
17 serial and badge numbers, gender, and race of each officer. Petitioner requested this information  
18 be provided in a character-searchable, electronic format. A true and correct copy of the request is  
19 attached as *Exhibit 1*.

20 8. **Respondent’s initial response:** Also on September 27, 2022, the Respondent  
21 acknowledged receipt of Petitioner’s request. On October 13, 2022, Respondent produced a list  
22 of sworn Torrance officers with their names and badge numbers, but refused to produce  
23 demographic gender and race information of any such officer, claiming exemptions per Penal  
24 Code section 832.7 and Penal Code section 832.8. A true and correct copy of Respondent’s  
25 response, including the produced record, is attached hereto as *Exhibit 2*.

26 9. **Petitioner’s reply:** On October 13, 2022, Petitioner renewed its requests for the  
27 demographic information of each officer, arguing that Respondent’s exemptions did not apply.  
28 To date, Respondent has not provided any further response.

1       **10. Respondent’s violations:** Respondent claims an inapplicable exemption: the information  
2 sought is not protected by Penal Code § 832.8, which limits protected documents of law  
3 enforcement officers to “(1) Personal data, including marital status, family members, educational  
4 and employment history, home addresses, or similar information. (2) Medical history. (3)  
5 Election of employee benefits. (4) Employee advancement, appraisal, or discipline. (5)  
6 Complaints, or investigations of complaints, concerning an event or transaction in which he or  
7 she participated, or which he or she perceived, and pertaining to the manner in which he or she  
8 performed his or her duties. (6) Any other information the disclosure of which would constitute  
9 an unwarranted invasion of personal privacy.” Pen. C. § 832.8. Simple demographic information  
10 such as race and gender (which is apparent to any individual who encounters any law  
11 enforcement officer) is not information protected per statute.

12                   **PETITION FOR WRIT OF MANDATE AND RELIEF PURSUANT TO THE**  
13                   **CALIFORNIA PUBLIC RECORDS ACT, GOV. CODE §§ 6250, et seq.**

14       11. Petitioner incorporates herein by reference the allegations above, as if set forth in full.

15       12. Petitioner is entitled to seek a writ of mandate and declaratory relief in response to  
16 violation of the CPRA. Gov. Code § 6258. Petitioner has no plain, speedy, adequate remedy in  
17 the ordinary course of law, other than the relief sought in this petition. Code Civ. Proc. §  
18 1086.31.

19       13. Respondent has a clear, present, ministerial duty to comply with Gov. Code §§ 6250, *et*  
20 *seq.* Respondent has repeatedly acted and continues to act in violation of the CPRA by denying  
21 access to public records and information through its failure to assist the Petitioner in identifying  
22 which records would contain the information sought, and its failure to produce code-compliant  
23 documents in requested electronic formats. Gov. Code §§ 6253.1, 6253.9(a)

24       14. Petitioner has performed all conditions precedent to filing this petition. There are no  
25 administrative exhaustion requirements under Gov. Code §§ 6250, *et seq.*

26       15. An actual controversy exists between the parties concerning whether Respondent has  
27 engaged in conduct that violates the statutory requirements of the CPRA. A judicial  
28 determination to resolve this actual controversy is necessary and appropriate at this time.

**REQUEST FOR RELIEF**

16. WHEREFORE, Petitioner respectfully requests judgement as follows:

17. That the Court issue a peremptory writ of mandate directing Respondent to make all requested documents available for inspection and provide a quote for direct costs of duplication of the records within 10 days of the Court’s order;

18. That the Court enter an order awarding Petitioner its costs of suit and reasonable attorney’s fees and costs incurred in bringing this litigation;

19. For such other relief as this Court deems just and proper.


